

**List of basic documents to be submitted for a visa application**  
**Embassy of Japan in Prague**  
*For Chinese passport holders*  
*Short-term visa for the purpose of visiting friends / acquaintances and family*

Please **do NOT** staple/clip/tab the documents

Each applicant must submit each own set of documents

We **do NOT** make copies

- **Valid Passport** (2 blank pages)
- **Copy of passport** (personal information page)
- **Copy of valid long-term visa OR long-term/permanent residence permit of the Czech Republic**
  - *the visa / residence permit has to be valid after the return to the Czech Republic*
- **1 visa application form:** <https://www.mofa.go.jp/files/000124525.pdf>
  - ❖ Please type or print legibly in black/blue ink (not pencil).
  - ❖ Please do not leave any questions blank (Please write N/A if the question does not apply to you).
  - ❖ Your signature must match your passport signature.
- **1 photo** (Czech standard passport-size: 35 x 45 mm, not older than 6 months)
- **Documents to prove ability to pay for travel expenses**
  - *bank account statements for the last 3 months*
  - *name of the account owner, transaction history, initial and final balances must be clearly visible*
- **Air ticket reservation** (with name, arrival and departure dates)
- **Accommodation reservation** (if available; with name of the applicant)
- **For spouse and children applicants:**
  - Copy of Marriage Certificate w/ Translation
  - Copy of Birth Certificate w/ Translation
  - Sponsorship Letter
- **Documents to prove kinship**
  - *birth certificates or other certificates proving family relations*

- *pictures taken together (when visiting friends)*
- *e-mails, WhatsApp correspondence etc.*

  - b) *A certificate of deposit balance*
  - c) *A certificate of tax payment*
  - d) *A copy of counterfoil of final tax return with seal of reception of the Tax Office*
- **Certified copy of the family register *koseki tohon*** (not older than 3 months) or **Residence certificate (Juminhyo)**
  - *in case the guarantor is a Japanese national*
- **Copy of Japanese residence card** (both sides)
  - *in case the inviter is a foreign national*
- **Copy of inviter's passport** (page with personal data)

**Please submit all documents in English or Japanese (or with respective translations).**

**Bank account statements are accepted in Czech.**

**Please submit a set of documents for each applicant. You may not share your documents. We do not make copies.**

**During the application procedure, additional documents may be requested if deemed necessary.**

**The visa procedure takes about 1 week.**

**All documents for the visa application must not be older than 3 months since the date of their issue (except for the passport, visa/residence permit and photo).**
